- Tfal taht is-sittax għandhom jitnizzlu fl-applikazzjoni ta' wieħed mill-ġenituri.

## Notes

### Please read very carefully:

- Unless otherwise specified with an asterisk (\*), ALL fields in the application form have to be duly filled in. Incomplete applications will not be processed.
- Applicants with an ID number ending in (A) should include with their application either proof of their National Insurance Contributions payment (last payslip of month corresponding to date of application) or proof their spouse is covered by the Maltese Social Security (and copy of marriage certificate) or a copy of their Certificate of Entitlement.
- Children under sixteen should be included in the application of one of the parents.
- Applications may be sent to the Head of Entitlement Unit, Ministry of Health the Elderly and Community Care, 23 St. John Street, Valletta, VLT 2000, Malta.
- The application form should reach the Entitlement Unit at least five (5) working days prior to the collection of the EHIC. Therefore it is strongly suggested that if the application is sent by post, it should be sent at least two (2) weeks prior to collection. If it is indicated that the EHIC should be sent by post, a further two (2) weeks should be allowed for postage.
- The EHIC may be collected from the Entitlement Unit.
- Opening hours:  
Summer: Mondays, Wednesdays and Fridays between 9:00 and 12:30  
Winter: Mondays and Fridays between 9:00 - 12:00  
Wednesdays between 9:00 - 12:00 and 14:00 – 16:00
- The person collecting the EHIC must bring his/her own ID Card and the ID Card numbers of whom cards he/she is going to collect. No EHIC will be released unless the collector's ID Card is presented.
- If EHIC (card) is lost it will not be re-issued unless an affidavit or a police report is presented, together with a new application form.
- When the EHIC expires applicant must re-apply according to the above-mentioned procedures.
